



TERMS AND CONDITIONS OF SALE

Acceptance of your booking confirmation implies full and unreserved adherence to these terms.

1. RESERVATION AND PAYMENT

- **Deposit:** Upon booking, a deposit of **25% of the total stay amount** is required, plus a **€15** non-refundable processing fee, cancellation insurance (if selected), and a **€3** household waste disposal fee.
- **Balance:** The total balance of your stay must be paid at least **1 month before your arrival**.
- **Included:** Water and electricity consumption are included in the rental price. Parking for **one vehicle** is included (for both rentals and pitches).

2. CANCELLATION AND MODIFICATION

- **Cancellation Fees:** In case of cancellation, the deposit, processing fees, and insurance are non-refundable.
 - **Less than one month before arrival:** 50% of the total stay amount is due.
 - **Less than one week before arrival:** 100% of the total stay amount is due.
- **Early Departure or Late Arrival:** No refunds will be issued for late arrivals or early departures.
- **No-Show Policy:** Your reservation will be held for **24 hours** from the scheduled arrival date. After this period, without notification from you, the reservation will be cancelled and the full amount will be retained.
- **Insurance:** We recommend taking out our cancellation/interruption insurance during booking (rates and terms available on our website).

3. ACCESS AND STAY POLICIES

- **Rental Accommodations:** Check-in between **4:00 PM and 7:00 PM** | Check-out between **9:00 AM and 10:00 AM**. (Pillows/blankets provided; sheets/towels available for rent subject to availability).
- **Camping Pitches:** Check-in between **2:00 PM and 7:00 PM** | Check-out between **9:00 AM and 12:00 PM**.
- **High Season:** Rentals are available from Saturday to Saturday only. Short stays (min. 2 nights) may be available upon request.

- **Capacity:** No additional guests will be accepted if the maximum capacity of the rental is reached. Any false declaration (identity, number of guests) will result in the immediate cancellation of the booking.

4. SITE RULES AND SECURITY

- **Vehicles:** Vehicle access to the campsite is prohibited after **11:00 PM**. Additional vehicles and visitors must park in the free municipal parking lot (50m away).
- **Identification:** Wearing the identification bracelet is mandatory during high season. Visitors must register at the reception and pay the visitor's fee.
- **Pool & Terrace: Swim shorts are strictly prohibited** in the swimming pool. Rules for the pool and the naturist terrace must be strictly followed.
- **Equipment:** Only **electric** barbecues are permitted (charcoal and gas barbecues are strictly prohibited by local government order).
- **Electric Vehicles:** Charging electric vehicles at the campsite's electrical boxes or inside rentals is **strictly prohibited** (insufficient amperage).
- **Cleaning and Damages:** If the rental is not returned in perfect clean condition, a **€120** cleaning fee will be charged. Any damage to equipment will result in a charge corresponding to the cost of the damage.
- **Pets:** Pets are not allowed in our establishment.
